OUR THEME, ROOTED IN POSSIBILITY, CELEBRATES THAT HOPE CAN BE FOUND IN THE UNKNOWN THROUGH ARTISTIC EXPRESSION BRINGS TO THE ARTIST, THE VIEWER, & THE COMMUNITY.

THE BASICS:

ROOTED IN POSSIBILITY ART AUCTION AND EXHIBITION IS A JURIED ART SHOW. CURATORS WITH PROFESSIONAL ARTISTIC BACKGROUNDS ALONG WITH RCA STAFF WILL BE SELECTING THE ARTWORK THAT WILL BE AUCTIONED AND EXHIBITED.

- River City Advocacy will retain 100% of all sales.
- 2D and 3D artwork will be accepted! Artwork should be ready to display upon purchase. **(Application deadline is October 22nd, selected art work should be dropped to RCA by November 4th.)**
- Acknowledgements for 1st, 2nd, and 3rd place will be given, as well as other recognition.
- Artists are encouraged to promote their websites and work! Bring business cards!
- All juried works will be included in online publicity and advertising for the show.

ROOTED IN GRATITUDE ART AUCTION AND EXHIBITION REQUIREMENTS:

- **Submission Form** - Email submission is preferred, but postal mail is also accepted. There is no fee to participate. Submissions must include an “about the artist” statement, and a short paragraph explaining how “Possibility” is represented in each work. - **Donations** - RCA will retain 100% of all sales, which will benefit our counseling center.
- **Acknowledgements** - Artists donating 100% of proceeds will receive special recognition. Certificates for acknowledgements will be mailed within 60 days of show.
- **Eligibility and Judging** - The auction is open to all original media (2D & 3D). No reproductions please. Works will be juried based on submitted photographs. Artists agree that all accepted work will be for sale the day of the auction, November 18, 2018.
- **Images** - Please send 2 images for each artwork entry. Title images with this format: Last name, First name, and Title of the work. (example: Smith_John_Still Life1.jpg). The quality of your artwork image affects jurying. Submit high-quality images of the artwork only.
- **Delivery of selected works** - All works must be appropriately framed and ready to hang or display. Canvases must have borders/edges painted. RCA is not responsible for works framed/mounted in an unstable manner. Only selected work will be included in the show, no substitutions. All jury selected art for Rooted in Gratitude should be delivered to River City Advocacy by November 4th, 2018. Please attach a business card size identification label on the back of each entry including the following information:
Artist name, phone # and email address, name of art work, and medium.
- **Liability** - Although care will be taken to protect all art work, RCA cannot be responsible for damage or loss.
